The Team, which finished the season undefeated (36-0), defeated West Windsor-Plainsboro High School South, 4-1, to capture the Group IV State Championship on May 26th, and then won the championship match of the Tournament of Champions by defeating Delbarton, 4-1, on June 2nd, thereby staking their claim as the best high school boys tennis team in New Jersey!
